| Staff have been thoroughly trained in all programs and have a current Working with Vulnerable People registration. | Injury due to allergic reaction to contact with plants, pollen or insects. | <ul style="list-style-type: none"> • Closed non-slip sole shoes are recommended • Avoid contact with plants and insects • At risk students wear long pants and long-sleeved shirts/blouses. • School inform students at risk, and bring appropriate medications e.g. Ventolin, epi-pens. • Jack Jumper ant nests are removed from places with high visitor traffic. Students should be warned not to approach any ant that appears to jump. |
| Key Ranger staff are trained in First Aid. | Injury due to fire on-site or in surrounding area | <ul style="list-style-type: none"> • Regular Hazard Reduction burns undertaken in ANBG southern annex and on Black Mountain • Emergency Management Plan developed, wardens trained and liaison with neighbours on emergency planning • Fire suppression sprinklers installed around boundary fence • In case of high fire danger, upper areas of the Gardens will be closed, activities will be in open lower area only. • In the case of catastrophic fire danger, the Gardens will be closed to all visitors. • Booked schools will be contacted to inform of any closure. |
| | Injury due to severe weather / high winds | <ul style="list-style-type: none"> • In the event of strong winds and other severe weather the ANBG may be closed in part or full, and evacuated as per ANBG policies and procedures. • The Gardens is closed for extreme weather and school bookings are cancelled. • Regular assessments of trees and appropriate actions taken for trees at risk of dropping branches • ANBG Staff use their judgement to cease a program if weather suddenly becomes severe during a program. |
| | Injury due to sunburn or exposure | <ul style="list-style-type: none"> • Participants to wear appropriate clothing for the weather <ul style="list-style-type: none"> ○ Summer: sun hats, sun screen, carry water and seek shade ○ Wet weather: waterproof clothing ○ Cold weather: warm clothing |

| | <p>Lost Student</p> | <ul style="list-style-type: none"> • Procedures are in place for lost children in the Garden documented in the ANBG Emergency Management Plan • Teachers are provided with Ranger mobile contact 0417 021 558 to assist with any emergencies. |
| | <p>Injury due to fall into water</p> | <ul style="list-style-type: none"> • Schools are advised that there are bodies of water in the Gardens so that they can provide appropriate supervision. • Education Rangers demonstrate to students how to work near water during programs which use ponds i.e. Pond Dipping |
| <p>Staff have been thoroughly trained in COVID safety best practice (including physical distancing, cleaning, sanitisation and hygiene), with procedures to ensure the safety of groups on site.</p> | <p>Illness due to direct or indirect contact with another person who has contracted COVID-19.</p> | <ul style="list-style-type: none"> • Maximum education program group size limitations in place, with relevant further indoor gathering limitations (e.g. person per x square metres), adhering to the current ACT government restrictions. • ANBG staff maintain a distance of at least 1.5 metres between themselves, other presenters and all group attendees. • All education program equipment is disinfected prior to use and control measures are in place to ensure there is no shared equipment use. • All indoor spaces used for education program purposes are cleaned and sanitised in preparation for use. • All education programs have hygiene and hand sanitising stations provided at the Banksia Centre (Education & Learning Building), in good condition and adequately stocked. • ANBG staff must stay home if they are feeling unwell or if they have been in close contact with a person who has or is currently being tested for COVID-19. |
