<b>Heritage Value</b>	The Royal Australian Mint received Commonwealth Heritage Listing in April 2016. The Mint is a heritage destination, and has significant importance in Australia's cultural history.		
<b>Local Climate</b>	Canberra has four distinct seasons. Summers can be hot, with average temperatures ranging from 12.7 to 27 ° C. In January, temperatures can consistently linger around the high 30s for several days. In hot weather, it is highly recommended to wear protective sunscreen/clothing and carry ample water. Winter days, whilst typically sunny and clear, can be cold, particularly in the mornings. Students should come prepared with adequate clothing for frosty mornings. Average temperatures range 1 – 12°C. Autumn and Spring are mild, with cool nights.		
<b>Working with Children Checks</b>	It is a condition of employment that all tour guides have a valid and updated Working With Vulnerable People Check in the ACT.		
<b>COVID-19 Safeguards and Etiquette</b>	Throughout the COVID-19 pandemic, the Royal Australian Mint is closely following advice from Federal and Australian Capital Territory Government bodies regarding reopening the venue to schools and general visitors, and the necessary precautions to ensure the health and safety and staff and visitors. Hand sanitising stations are located throughout the public areas of the building. Visitors who are not part of organised tours are being asked for contact details for tracing purposes, and a single-direction walking route has been established in the gallery area. <b>Photography and filming</b>	<p>The Royal Australian Mint is open to the general public as a tourist attraction with excess of 330,000 visitors per year. Other visitors will often take photographs. Teachers should abide by any guidelines their own school has, in regards to the photography of students. On occasion, international visitors may not be aware that Australian schools have these policies. Teachers should exercise diplomacy and employ the assistance of RAM staff, should they encounter visitors attempting to take photographs of students.</p>
<b>Duty of Care / Student Behaviour</b>	<p>Duty of Care requires that all students must be accompanied by a teacher or responsible adult associated with the school at all times whilst at the Royal Australian Mint. Please bring sufficient staff / adults to ensure that this is possible. <b>Student to Teacher/Adult Supervisor ratio to be maintained at one adult per 30 students at all times.</b> All teachers and adults accompanying the school group are responsible for the behaviour of students in their care,</p>

<b>Toilet facilities</b>	We have toilet facilities on both the ground floor (entry level) and on the first floor (prior to entering the gallery). Both levels include disabled toilet facilities. Due to our environmental policy, only air hand dryers are provided (except in the disabled toilets). Please allow sufficient time for student use of the toilets before or after your program.
<b>Other requirements</b> <i>Where relevant, list other requirements that participants are required to bring.</i>	<b>Students are not to bring bags or back packs into the Mint larger than A4 size, and must remain with the student at all times. We strongly recommend all bags (excluding wallets/purses remain on the bus).</b> However, they may wish to bring some money with them, to purchase souvenirs in our gift shop or mint their own coin in the coin press (\$3 each). All bags or back packs brought into the Mint may be subject to a Security check which may involve X-ray and physical examination as well as metal detector sweeps of individuals.
