**It is hereby noted and agreed that the Statement of Cover is amended as follows:**

**Property**

- Effective 01/07/2008 In respect of all works of art/exhibitions on loan. The excess shall be \$1,000. The Lender shall have the right to repurchase from Comcover, property of the Lender that is recovered, for a fair market value at the time of recovery. Damaged property of the Lender, for which a total loss has been paid, may be repurchased by the Lender at the then fair market value of the damaged property. Comcover agrees to notify the Fund Member/Lender of it's right to purchase damaged or recovered Property and the Lender shall have sixty days from the date of notice to exercise the repurchase right. The Lender in exercising this right, shall furnish Comcover with copies of the proof of loss, Police report and claim draft involving such property.

**In all other aspects the Statement of Cover remains unaltered.**
