

## **National Capital Teacher Pass Terms & Conditions**

### **Purpose**

The National Capital Teachers Pass provides teachers access to participating National Capital Attractions whilst visiting Canberra, so they can explore opportunities available for planning a school excursion.

The Pass is not to be used during a Canberra excursion, as

Referred to as 'the Pass' for the purposes of these terms and conditions.

### **1. Administration**

- 1.2 The National Capital Educational Tourism Project (NCETP) manages the Pass application and approval process on behalf of participating attractions.
- 1.3 The NCETP reserves the right to refuse a Pass application if correct information is not received.
- 1.4 The NCETP has the discretion to negotiate the supply of alternative information on a case-by-case basis.
- 1.5 Pass applications will be approved within a 48-hour timeframe in most cases.

### **2. Eligibility**

- 2.1 The Pass is available to registered Australian primary, secondary and tertiary teachers who are actively participating in education.
- 2.2 Proof of registration is required depending on the state or territory within which a teacher is registered, as follows:

ACT – Australian Capital Territory Teacher Quality Institute

NSW – New South Wales Education Standards Authority

NT – Teacher Registration Board of the Northern Territory

QLD – Queensland College of Teachers

SA – Teachers Registration Board of South Australia

TAS – Teachers Registration Board of Tasmania

VIC – VIT (Victoria Institute of Teaching)

WA – Teacher Registration Board of Western Australia

Homeschools – student identification number or copy of certificate

- 2.3 The NCETP has the discretion to negotiate alternative proof on a case-by-case basis.

### **3. Pass validity**

- 3.1 The Pass is valid for 12 months from date of issue.
- 3.2 If your Pass has expired you will need to reapply at [Canberra Excursions](#).

#### **4. Participating organisations**

- 4.1 Current offers from participating attractions and other relevant organisations are available at [Canberra Excursions](#).
- 4.2 Participating organisations may change their offers at any time.
- 4.3 The Pass is non-transferrable, and organisations have the right to ask for proof of identity when a Passholder presents a Pass.
- 4.4 Participating organisations may refuse entry or not apply a Pass offer at their discretion.

#### **5. Immediate family**

- 5.1 Immediate family refers to the Pass holder, 1 other adult, and up to 3 children.
- 5.2 Participating attractions have the discretion to extend this for additional children under the age of 16 years

#### **6. Homeschools**

- 6.1 Only 1 pass will be issued per Home school.
- 6.2 The Pass is not to be used by a Home school on an excursion.
- 6.3 The Pass can't be used by Passholders travelling in a group with more than 2 other Passholders.
